

APT Innovation Awards 2023 - Terms and Conditions

Introduction

1. By entering the APT Innovation Awards promotion 2020 you agree to be bound by these Terms and Conditions of the Promotion and any instructions relating to the promotion as outlined on the APT, Corian®, and Fenix® websites.
2. APT may in its absolute discretion refuse to award any Prize to any entrant who fails to comply with these Terms and Conditions.

Promotion Period

3. The Promotion commences 1st March 2023 and concludes 31th May 2023.

Entry Criteria

4. An entrant of the promotion must be a Specifier, Architect/Designer or Design Student and must have included one or more of the APT Brands, Corian® Solid Surface or Fenix, as part of their project design.
5. There will be 3 categories – Commercial, Residential and Emerging Talent.
6. A project entered on the Commercial or Residential categories can also be submitted to the Emerging Talent category.
7. There is no limit on the number of projects entered into the promotion.
8. At the end of the submission period finalists will be shortlisted, and an overall winner chosen for each category by an independent judging panel.
9. All projects specified and completed between September 7th 2013 and May 31st 2023 are eligible.
10. All images must be supplied with high resolution (300dpi or greater). Please talk to our team if these are not available.
11. By submitting an entry, all entrants warrant that they have permission from all parties including clients, copyright holders and collaborators to allow APT and its partners to publish their work on their website, media partners, and in any associated promotion materials, without limitation. This includes professional photography – APT will not pay for the use of any photography that has been completed by professional photographers, this needs to be organized by the entrant prior to entering the promotion.
12. By entering, you indemnify APT, its employees and agents and supporting partners from any liability for the wrongful use or misrepresentation of the works submitted. You assert that you are the creator of the work and own the intellectual and moral rights to the work under the Copyright Act. Wrongful assertion of such rights will render the entry invalid and the entrant accepts all liability for any claim for damages or loss resulting from such wrongful assertion.
13. By entering, you assert the truthfulness of this information and assign copyright of your entry text to APT, further authorizing the editing and publication of the project statement by APT and its partners on the Corian® NZ, Fenix® NZ websites and in any associated promotional materials, without limitation.
14. All entrants must obtain permission from the commissioning client to enter the project into the awards.
15. Any entries that are subsequently found to breach any of the Terms and Conditions of entry will be ruled invalid and withdrawn from consideration for the Promotion.

16. In the event that an award winner is subsequently found to breach any of the Terms and Conditions of entry, their work may be ruled invalid and the award deemed null and void. The entrant will be liable for any costs incurred and must forfeit the prize received.
17. All entries may be used for other APT marketing purposes e.g. print or digital advertising, at the discretion of APT.
18. Terms and Conditions may be amended, deleted, or added from time to time at our discretion and we will publish the revised Terms and Conditions on the website. By checking the box on the online entry form you agree to the full Terms and Conditions so please read them carefully.
19. The overall winner will be selected by an independent judging panel assembled by APT. The overall winner in each category will be selected and announced in September 2023.
20. All judges' decisions are final, and no correspondence will be entered into relating to the judging process or the outcome.

Prize

21. The Prize for Commercial and Residential categories is a FREE premium economy flight for 2 to Los Angeles including transfer to departure city, transfers to Palm Springs from Los Angeles and accommodation for Modernism Week. The prize for Emerging Talent category is a gift package valued at \$1,000 and a media package valued at \$1,000.
22. Reasonable notice of the departure date will be given to the prize winner.

Prize Restrictions

23. APT will not be responsible for any additional costs associated with the Prize. The prize winner (and, if applicable, their guest) is responsible for all incidental costs associated with the Prize including (if applicable) travel and/or transfer costs (unless otherwise specified) expenses with food and beverages, travel and medical insurance costs and spending money.
24. The prize winner must be available to redeem the prize on the dates stipulated by APT. If the prize winner is not able to redeem the prize on that date, then the prize will be forfeited.
25. The prize will be awarded to the lead designer if the project has been completed by a team, should the lead designer be unable to claim the prize the prize will go to the next nominated designer within that team (this person is to be decided by that team).
26. No component of the prize can be transferred or redeemed in cash.
27. All prizes are subject to availability. If any of the Prizes or parts of the Prize becomes unavailable due to circumstances beyond APT's reasonable control, we reserve the right to provide a similar product to the same value as the original prize.
28. It is a condition of accepting the prize that the winner (and any guest participating in using the prize) must comply with all the conditions of that use of that prize and APT requirements.
29. Each Prize includes flights, entrants agree that (a.) The Prize does not include transfers to and from the winner's place of residence to the departure point and transfers between the accommodation and airport (unless otherwise specified); (b.) The flights must be utilized at the same time, for the same travel dates, to and from the same destination; (c.) No frequent flyer (or equivalent rewards program) points will accrue to the Prize winners (and any guest participating in using the prize) on the prize flights or accommodation; and (d.) The booking time of the flights will be determined by APT's travel agent in its complete discretion.
30. The prize includes accommodation, it is a condition of accepting the prize that the prize winner may be requested to present their credit card or a cash deposit upon arrival at any

accommodation to cover all ancillary costs they may incur during their stay. For the avoidance of doubt, the prize winner acknowledges that the accommodation part of the prize includes room charges only (and no ancillary costs such as room service).

31. It is up to the winner of the Prize to ensure they have an up-to-date passport with enough time for travel before expiry. The prize winner will also need to ensure they are eligible for Visa to visit Los Angeles and organize their Visa themselves.
32. All components of the package(s) must be taken together.
